# **Assessing Impact of COVID-19**

## I. Introduction

Catholic Volunteer Network put together a survey meant to give our member programs a look at recent programmatic changes, recruitment numbers, finances and other areas impacted by COVID-19. This 5-minute survey was open from June 16<sup>th</sup>-25<sup>th</sup>. 70 member programs participated.

## a) Domestic vs. International

- o 64% of programs place volunteers domestically
- o 14% of programs place volunteers internationally
- o 22% of programs place volunteers both domestically and internationally

#### b) Short-term vs. Long-term

- o 9% of programs offer short-term volunteering opportunities
- o 64% of programs offer long-term volunteering opportunities
- o 27% offer both

# II. Programming

- 80% of programs who participated in the survey said they are still planning to place volunteers in programming for 2020-21. The rest (20%; 14 programs) said no or unsure.
- Of the 20% who are not planning to have volunteers in 2020-21, 3 programs said they have volunteers committed to their program who now need/want a new program to volunteer with.
- Of those 80%, 63% (56 programs) are still actively recruiting/accepting applications for the upcoming volunteer cycle.
- 294 total volunteer slots still need to be filled.

# III. Opening Retreat and Orientation

- Most programs (77%; 41 programs) reported their opening retreat/orientation will happen on-time instead of delayed.
  - 45% are hosting an in-person retreat/orientation.
  - o 33% are using Zoom.
  - o 13% said other.

#### IV. Finances

- 68% (46 programs) are currently fundraising while 32% (22 programs) are not.
- 48.5% (33 programs) are expecting a loss of revenue.
- 48.5% (33 programs) are expecting a decrease of expenditures while 21% (14 programs) are expecting an increase.

# v. Resources and Other Programming Changes

- 66% (43 programs) are in the process of modifying their materials to include waivers or procedures related to COVID-19.
- List of common changes being incorporated into programming are:



- Volunteers will be quarantined together for two-weeks before starting at their placement site.
- Required COVID-19 testing for volunteers
- Ongoing temperature checks of volunteers
- Volunteers will sign a COVID-19 waiver.
- o Require face coverings/masks.
- o Include virtual volunteer opportunities.
- o Travel and visitor restrictions for volunteers.
- Following the lead of the placement sites and what they requirement.
- o Change housing/community living arrangements.
